

1. **CALL TO ORDER** The City Council Workshop meeting was called to order by Marion Bishop at 2:00 p.m.
2. **EXECUTIVE SESSION-CLOSED SESSION**
 - a. City Council will convene in Executive Session in accordance with the Texas Government Code Section 551.072 deliberation regarding the purchase, exchange, lease, or value of the real property.
The City Council convened into an executive session at 2:01.
3. **EXECUTIVE SESSION-OPEN SESSION**
 - a. City Council will reconvene in Open Session for discussion and possible action regarding the purchase, exchange, lease, or value of real property.
The City Council reconvened into open session at 2:28 p.m. No action was taken.
4. **WORKSHOP AGENDA ITEMS**
 - a. Discussion regarding the FY 2023-24 City of Llano Budget.
A motion was made by Alderwoman Gilliland, with a second by Alderman DeCesaris to convene into an executive session to discuss the purchase, exchange, lease, or value of the real property. All in favor, none opposed. Motion carried. The City Council convened into executive session at 3:11 p.m. and returned to open session at 3:34 p.m. No action was taken.
5. **ADJOURNMENT** The Council adjourned at 4:01 p.m.

If a Closed or Executive session is held in accordance with the Texas Government Code as set out above, the City Council will reconvene in Open Session to take action, if necessary, on the items addressed during Executive Session. Although a quorum of the members of other Boards or Commissions, may or may not be in attendance, this notice is being posted to meet the requirements of the Texas Open Meetings Act and subsequent opinions of the Texas Attorney General's Office.
