

**CITY OF LLANO
RESOLUTION NO. 2017-03-20-1**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LLANO, TEXAS, DECLARING THE UNOPPOSED CANDIDATES FOR THE OFFICE OF ONE (1) MAYOR AND TWO (2) ALDERMAN AS ELECTED; PROVIDING THAT THE MAY 6, 2017 GENERAL MUNICIPAL ELECTION FOR ONE (1) MAYOR AND TWO (2) ALDERMAN AT LARGE SHALL NOT BE HELD; FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS RESOLUTION WAS PASSED WAS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Llano, Texas ordered on February 6, 2017, that a general municipal election be held on May 6, 2017, for the purpose of electing three At-Large officials of the City, of which one is Mayor and two were Alderman At-Large positions.

WHEREAS, pursuant to Sections 143.007 and 146.054, Texas Election Code, the deadline for filing applications for a place on the ballot and declaration of write-in candidacy for the City's general municipal election has expired; and

WHEREAS, The City Secretary, in accordance with Section 2.052, Texas Election Code, has certified in writing (Exhibit A) to the City Council that **Gail Lang** is unopposed for election to the office of Mayor, **Craig Bauman** is unopposed for election to the office of Alderman, and **Kelli Tudyk** is unopposed for election to the office Alderwoman.

WHEREAS, The City Council hereby finds and determines that there were no declared write-in candidates.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF LLANO, TEXAS:

SECTION 1. That the facts and matters set forth in the preamble of this Resolution are hereby found to be true and correct.

SECTION 2. In accordance with Section 2.053(a), Texas Election Code, the following unopposed candidates are hereby declared duly elected and shall be issued a certificate of election following the date on which the general municipal election for all three Alderman was to have been held:

Mayor – Gail Lang
Alderman – Craig Bauman
Alderwoman – Kelli Tudyk

SECTION 3. Pursuant to Section 2.053(b), Texas Election Code, the general municipal election for heretofore called and ordered by the City Council for May 6, 2017 shall not be held and is hereby cancelled (Exhibit B).

SECTION 4. The City Secretary is hereby directed to cause a copy of the Order of Cancellation to be posted on election day, same being May 6, 2017, at the polling place(s) that would have been used in such election (Exhibit B).

SECTION 5. Should any section, paragraph, sentence, clause, phrase or word of this resolution be declared unconstitutional or invalid for any purpose by a court of competent jurisdiction, the remainder of this resolution shall not be affected thereby and to this end the provisions of this resolution are declared to be severable.

SECTION 6. It is hereby found and determined that the meeting at which this resolution was passed was open to the public as required by Section 551.001 et. Seq., Texas Government Code, and that advance public notice of the time, place and purpose of said meeting was given.

SECTION 7. This resolution shall take effect immediately after reading.
